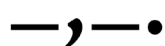

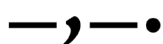

1. Foreword

by Pier Giovanni Capellino

In 2023, the European Commission, in a historic move, published a Proposal for a new Regulation on the Welfare of Dogs and Cats, and their Traceability. When adopted, this legislation will, for the first time in the history of EU law, establish animal welfare standards for breeders and sellers of cats and dogs, mandate microchipping and registration as part of the sales process, and strengthen regulations to reduce the risks of illegal trafficking.

This proposal is ground-breaking because until now EU legislation had only dealt with companion animals as vectors of disease (in animal health regulations) or as commodities (in transport legislation), rather than as sentient beings whose existence carries an ethical component.

The recent discussions that have taken place in the EU institutions over the past couple of years have shown that consensus among policymakers is within reach. However, this consensus needs to be stronger to capitalize on this unprecedented opportunity to change the lives of millions of animals.

The first game-changing amendment policymakers must push for is the mandatory microchipping and registration of all cats and dogs across the Union. Currently, the proposal calls for the mandatory registration only of cats and dogs who are sold by commercial breeders and sellers – including online sales. However, the mandatory registration of all cats and dogs, e.g., those born and kept in private homes, is needed to ensure that all cats and dogs receive adequate treatment, are prevented from being trafficked, and can be reunited with their guardians in the event that they are lost.

In some instances, identification and registration could be a valuable tool to identify and prosecute neglectful and abusive owners, especially in the case of pet abandonment, which is widespread in the EU. This obligation to register animals should also apply to online sellers before they advertise an animal for sale, which would effectively end the illegal trafficking of cats and dogs that has become endemic in Europe over the past two decades.

A second crucial amendment would be to make national databases of registered cats and dogs interoperable, ensuring their effectiveness in prosecuting traffickers but also finding a pet lost in a country other than the one where it was registered. The EU is uniquely positioned to implement this simple yet powerful measure, which would instantly boost cross-border reunifications and protect pets on a continent-wide scale.

A third and final amendment that would make this legislation truly revolutionary for the EU's cats and dogs: the EU must mandate minimum criminal penalties for those who violate these critical welfare standards, sending a strong message that animal cruelty will not be tolerated. Currently, companion animal abuse by professional breeders and private citizens is not meaningfully penalized in the criminal law of the 27 EU Member States, allowing grievous abusers to walk with nothing more than a slap on the wrist. This legislation, however, offers EU policymakers an unprecedented opportunity to tackle a critical gap on an EU-wide scale, setting a bold standard for animal welfare across the Union. Strengthening deterrent penalties would also send a powerful message of support to animal advocates and shelters, who bear the secondary brunt of abuse and abandonment, with animals being the primary victims.

As it stands, the legislation on cats and dogs sets the ground for the recognition of the human-animal bond, the uniqueness of animal life, and the species-specific needs of companion animals. These common-sense measures are not just necessary; they are a reflection of the values that the EU holds dear—compassion, responsibility, and respect for all living beings.

The European pet food industry estimates that there are 72,7 million dogs and 83,6 million cats in households across the EU.¹ Accordingly, the breeding and trade of cats and dogs in the EU is also a profitable economic sector, valued at over EUR 1.3 billion annually.² Europeans have strong attachments to cats and dogs, as 44% of EU citizens live with companion animals and a large majority of EU citizens (74%) feel strongly that dogs and cats should be better protected.³

2.1. Inadequate Protection Against Cruel Treatment by Breeders, Traffickers, Sellers, and Owners

Yet, these animals are insufficiently protected under EU law. Cats and dogs are victims of traffickers who exploit them for profit, posing risks to their welfare and public health at large. A 2023 study by the European Commission presented evidence of an important volume of document forgeries and misleading information in support of puppy trafficking.⁴ This study further showed that traffickers disguised the movement of dogs for commercial purposes as noncommercial movements to take advantage of less stringent control rules, and were able to do so on account of inadequate enforcement rules.⁵ In a 2024 report, the animal advocacy organization Four Paws further estimated that 4.75 million dogs in the EU come from unknown or illegal sources.⁶ The lack of traceability in dogs, and more particularly puppies, is all the more problematic since the demand for dogs exceeds the number of dogs presently in the EU, leading prospective owners to turn to breeders who do not operate legally, in and outside the EU.⁷ The use of the internet to advertise the sale of puppies and kittens, through classified ads websites (e.g. Craigslist) or social media has further fueled illegal trade.⁸ It is estimated that around 60% of dog and cat owners purchase their animals on the internet, representing around 4.8 million dogs and 1.2 million cats.⁹

The lack of traceability in kittens and puppies often goes hand in hand with abuse in breeding facilities and during transport, often conducted by organized crime groups. Forgeries in animal health documentation often hide the fact that the animals are not administered necessary vaccines.¹⁰ Besides not being vaccinated against rabies, which is a legal requirement, cats and dogs are also often unvaccinated against dangerous diseases common in young animals, such as Parvovirus, distemper and Leptospirosis in dogs, and Parvovirus, Herpes-, and Calicivirus in cats, all of which can be fatal to them and other animals in their surroundings. The cruel treatment of animals in breeding facilities,

often referred to as "puppy mills" or "kitten mills," where young animals are separated too early from their mothers, and the inadequate conditions of transport often exacerbate the risk of contracting diseases.¹¹ A 2022 investigation by Four Paws revealed that a disproportionate amount of puppies bought through social media become unwell, with some puppies dying.¹²

In the absence of stringent standards under EU and most national law, cats and dogs can also suffer in legal breeding and selling facilities, such as pet shops. Not all Member States regulate breeders by requiring that they comply with minimum animal welfare standards, such as minimum space allowance, enrichment specifications, or outdoor access. Many EU Member States still allow the sale of cats and dogs in pet shops, where the animals stay enclosed for days in conditions that undermine their welfare, and promote compulsive purchasing behaviors that are not in the animals' best interest.

The lack of regulation in the sale of dogs and cats also means that these animals can suffer in homes, after they are adopted. Very few Member States impose restrictions on the sale and ownership of companion animals, thus allowing virtually anyone, including underage persons, to own an animal. And in the absence of mandatory identification and registration of cats and dogs in the EU, enforcement authorities are not able to identify and prosecute owners who abuse or abandon their animals.

2.2. German Case Study

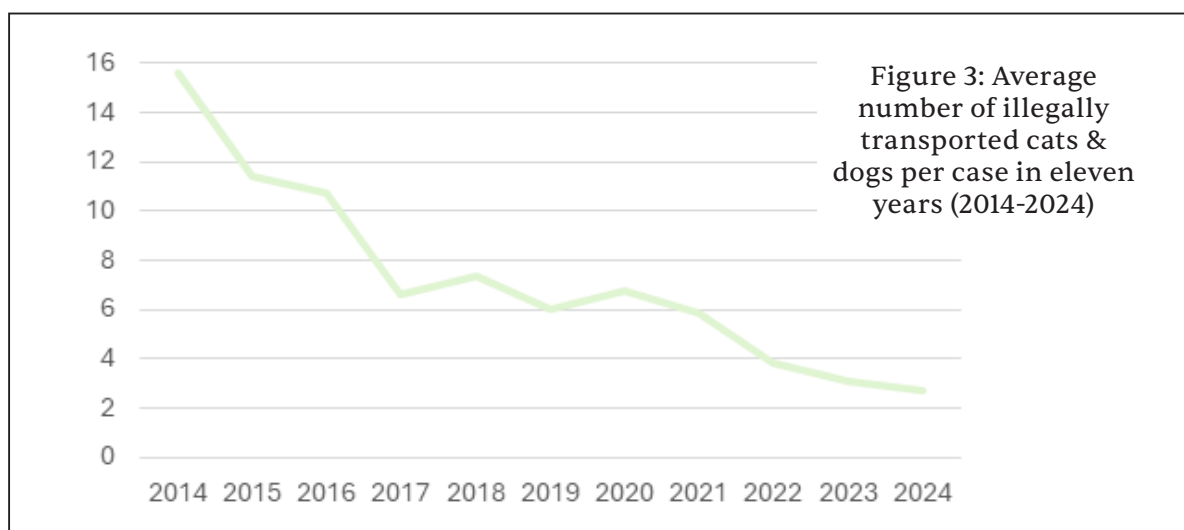
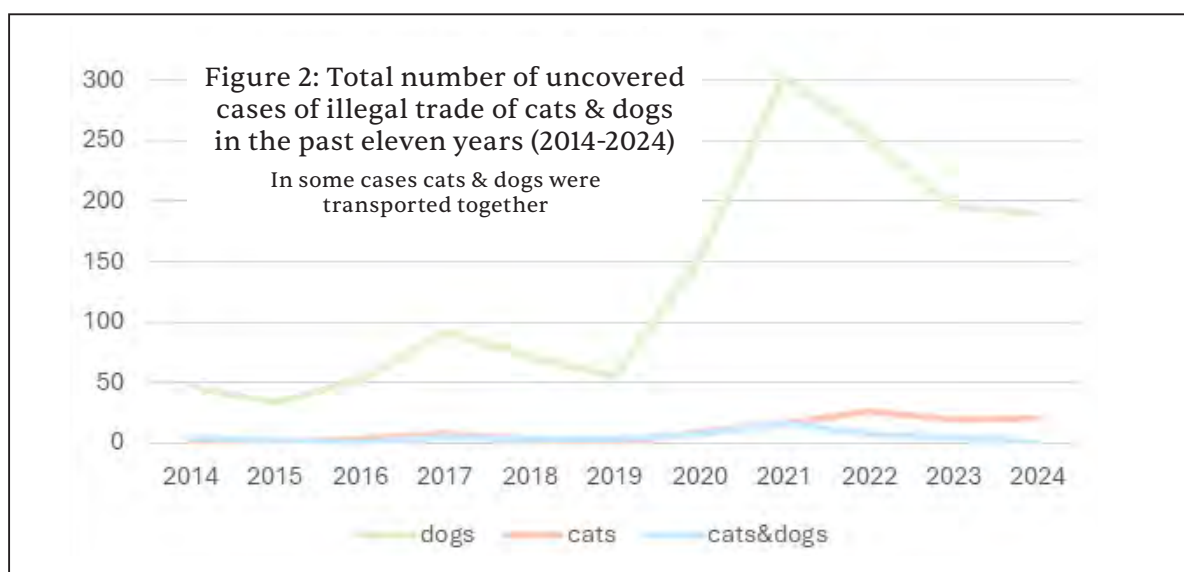
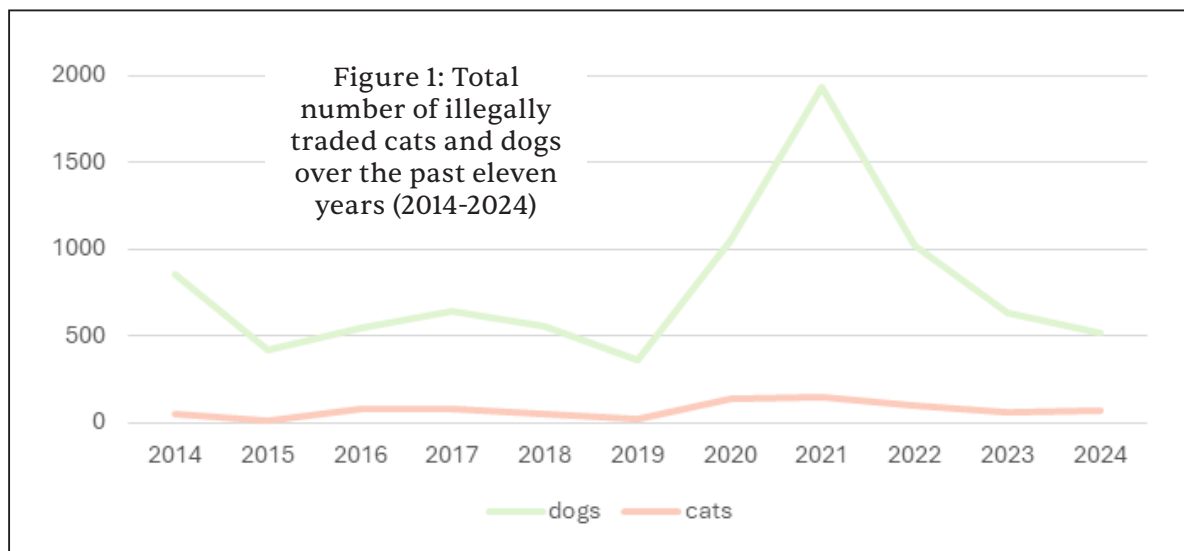
THE ILLEGAL TRADE OF CATS AND DOGS INTO GERMANY: IMPACTS ON ANIMAL SHELTERS

The Deutscher Tierschutzbund e.V. (German Animal Welfare Federation) has been monitoring and evaluating cases of illegal pet trade for over a decade. In particular, the illegal trade in dogs and cats has gained increasing significance, with Germany serving as a major hub for the trafficking of these animals.

Over the past 11 years (2014 to 2024), Deutscher Tierschutzbund has documented more than 1,600 cases of illegal cat and dog trade in Germany, with almost 9,400 individual animals being transported illegally. On average, 152 cases of illegal cat and dog trade have been uncovered every year over the past eleven years. Roughly speaking, this means that every third day at least one illegally traded cat or dog is discovered.

The years 2020 and 2021 were especially notable and influenced by the coronavirus pandemic. The demand for dogs and cats as companion animals rose to an all-time high. Legal and reputable sources were not able to cover the high demand, so illegal trade experienced a significant boost. The number of cases and sheer quantity of illegally traded puppies rose to frightening levels in these two years (see fig. 1 and 2).

Since 2022, as the pandemic has subsided, there has been a slight decrease in the number of documented cases of illegal dog and cat



trafficking. Looking at the consistently high number of cases in combination with the reduced total number of animals trafficked in 2024, it becomes clear that illegal trade is still taking place on a large scale, but unlike a few years ago, individual animals (or a smaller number of animals) are increasingly being smuggled and disguised as private sales, although there are illegal and commercial intentions behind this (see fig. 3).

In 2024, 212 cases of illegal cat and dog trade were reported with a total of at least 581 affected cats and dogs. Almost all of these animals were confiscated by the authorities. Non-confiscated animals were either permitted to move on to their destination, or some of the dogs or cats were already sold and stayed with the new owner. In 95 of the cases involving dogs (79%) where information was given, pure-breed dogs were traded. The most frequent reason for confiscation was a violation of the Animal Health Law (95%). In 79% of cases, the dogs and cats were too young to cross the border legally.

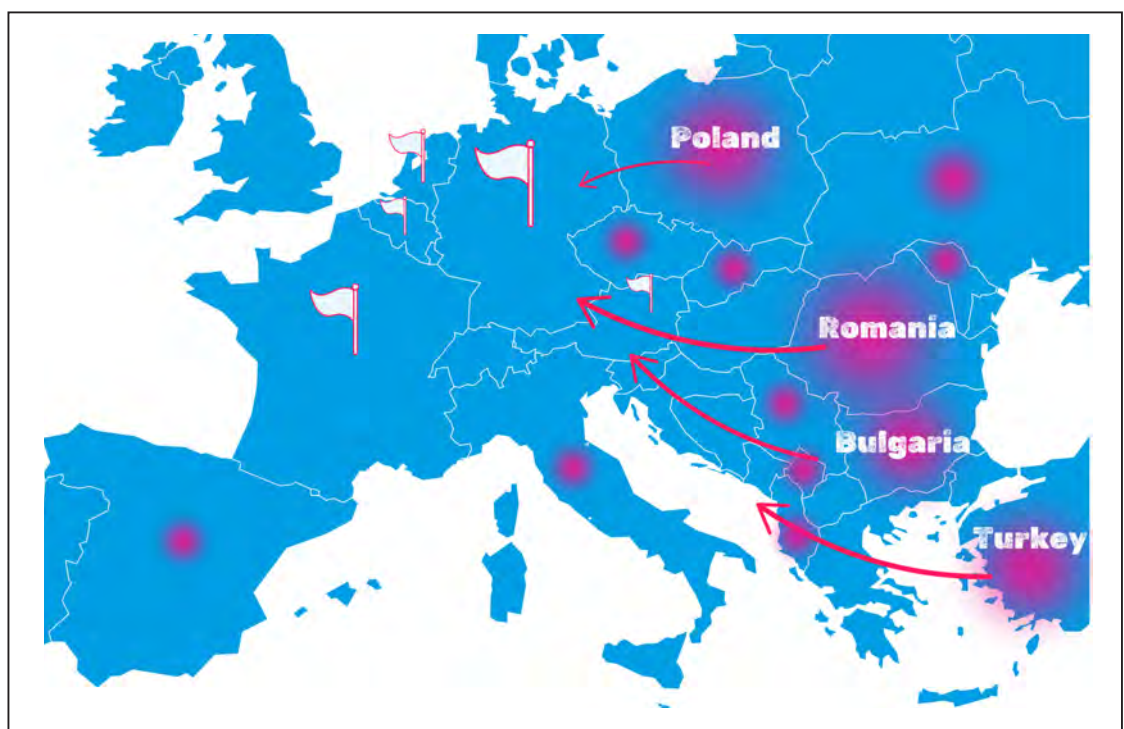


Figure 4: Typical countries of origin for illegally traded cats & dogs (eastern Europe) and destination countries

In 97 cases (45%), specific information was provided on the health condition of the animals. **In 80 of these cases (82%), the animals were sick.** In particular, in a large proportion of the cases, animals suffered from diarrhea (70%) caused by various endoparasites, such as *Giardia*, or by parvovirus, fig.4. Several illnesses from which the animals suffered pose potential risks to humans (zoonosis). Among the illegally transported dog and cat breeds were numerous animals with extreme features that required extensive and expensive veterinary care, fig 5.

In 2024, the animals came mainly from Romania (43 cases), Bulgaria (36 cases), and Turkey (11 cases), see fig.5. **Romania has been the most common country of origin for 9 years in a row.** In 74 cases (85%), where information was given, Germany was the country of destination; in 13 cases where the destination was known, Germany was only a transit country. Nearly half the cases - 94 (42%) - were detected in Bavaria.

In 2024, animal shelters and rescue centers were involved in the placement, care, and treatment of confiscated animals in almost all cases. **The cost of housing and caring for a dog or cat averaged 20 euros per animal, per day in 2024 (ranging from 15 to 33 euros).**

The 11-year review and the results for 2024 clearly show that the illegal pet trade has been a major problem for many years and is likely to remain so in the future. It is virtually certain that a very high number of unreported cases remain. The decline in the numbers recorded is still due to a probable saturation of the market, partly as a result of the significant increase in legal and illegal imports of dogs and cats during the first two years of the pandemic, as well as the barrier to getting a pet due to rising costs in all areas of life.

Shelters and animal welfare organisations all over Germany have been stretched to their personnel and financial limits. Cost increases have also made the work of shelters and other organizations even more difficult in recent years. To add to the existing problems facing animal shelters, caring for illegally traded animals represents an additional and avoidable load, which is becoming unsustainable.

To solve this problem, transnational measures need to be taken, **including an EU-wide obligation to identify and register dogs and cats, stricter rules for the online trade, increased public awareness, police and custom officials training, higher rates of controls, and tougher penalties for traders.** Further measures necessary to reduce the animal welfare problems caused by the illegal pet trade are the introduction of special legal regulations for the keeping and breeding of pets, which should include an obligatory certificate of competence before the acquisition of an animal. To avoid animal shelters bearing the costs, it is necessary to create legally binding measures to reimburse them. The European Commission's proposal on the welfare of dogs and cats and their traceability for the first time presents several approaches to regulating the uncontrolled online trade of animals. It introduces mandatory identifications and registration for traded cats and dogs, therefore offering a small glimmer of hope. However, the scope of this obligation must be extended to all cats and dogs for it to be effective.

Hard Facts: Illegal Trade of Cats & Dogs to Germany

2014 -
2024

More than **1,600 cases** of illegal trade with **8,552 dogs** and **803 cats**

Immense increase of illegal trade during the pandemic: comparing 2019 (before the pandemic) to 2021 (during the pandemic), the number of illegally traded dogs increased **fivefold**. The number of illegally traded cats increased **sixfold**.

Even if the total number of cases and animals has declined from 2022, the numbers are still high compared to pre-pandemic levels.

The number of illegally transported cats and dogs per case has **fallen** from an average of **16 animals per case** (2014) to **3 animals per case** (2024), which shows the adaptation of illegal traders, as small transports can be disguised under private (non-commercial) intentions.

212 cases of illegal trade with **515 dogs** and **66 cats**

There is a **decrease** in the total number of cases and number of dogs compared to 2023.

The total number of cases is still at a high level compared to before the pandemic.

Pomeranians, Maltese dogs, and French bulldogs are the most popular breeds.

In 80% of cases, animals were **too young** for a legal import.

In 80% of the cases, animals were **sick**.

Bavaria, Saxony, and Berlin were particularly affected by the illegal pet trade.

For 9 years, **Romania** has been the most common country of origin for illegally traded cats and dogs.

2.3. The EU's Competence in Ensuring the Welfare of Cats and Dogs

While the EU has never enacted legislation that specifically protects cats and dogs, the EU institutions have launched several initiatives aimed to improve the treatment of cats and dogs.

The European Parliament adopted a Resolution in 2016 calling on the European Commission to address the illegal pet trade, including through harmonized identification and registration rules for cats and dogs, and interoperable database systems.¹³ The Parliament also adopted a resolution in 2020 calling on the Commission to formulate an action plan against the illegal trade in companion animals, including by regulating online advertising and improving the enforcement of existing animal health laws.¹⁴

In response to these resolutions, the Commission published an EU Strategy to Tackle Organised Crime 2021–2025, in which it classifies the illegal trade of companion animals as a form of organized crime.¹⁵ The Commission (under the leadership of the Directorate-General for Health and Food Safety) also coordinated an enforcement program, called an “EU Enforcement Action,” from July 2022 to July 2023. This program detected irregularities and the falsification of the official documents accompanying companion animals (passports, rabies test reports, and health certificates), identified undeclared and unregistered sales, and reinforced inspections at EU borders and within the EU. This program led to the publication of a report in 2023, which provided an overview of trends in the illegal trade of cats and dogs, and the shortcomings of current rules in regulating such a trade.¹⁶

The European Food Safety Authority further produced a scientific opinion on the welfare aspects related to the housing and health of cats and dogs in commercial breeding establishments,¹⁷ which largely informs the Proposal by the European Commission, published in December 2023.¹⁸

While certain Member States have codified good practices into their national laws, taken together, the laws of the 27 EU Member States are inadequate to compensate for the shortcomings of EU law.

3.1. Identification and Registration Rules

Most EU Member States (e.g., Cyprus,¹⁹ Denmark,²⁰ Hungary,²¹ Ireland²² and Romania²³) provide rules on the identification and registration only for dogs, and only a few (e.g., France,²⁴ Lithuania²⁵ and Slovakia²⁶) also

mandate the identification and registration of cats. However, not all Member States ensure they have harmonized and interoperable databases at national and EU level.

3.2. Regulation of Breeding Activities

Most EU Member States also regulate the breeding of cats and dogs by way of professional licensing systems such as Austria²⁷, France²⁸, Germany²⁹, Sweden³⁰ or Bulgaria³¹. Moreover, a majority of EU Member States provide specifications for the keeping of cats and dogs in breeding facilities (such as Bulgaria³², Austria³³, Belgium³⁴, Croatia³⁵, Cyprus³⁶, or Germany³⁷). Only five EU Member States provide specific requirements for the commercial transport of cats and dogs stricter than EU Regulation 1/2005 on the protection of animals during transport. (Bulgaria³⁸, Croatia³⁹, Germany⁴⁰, Spain⁴¹ and Sweden⁴²). Overall, few Member States (Belgium⁴³, France⁴⁴, Croatia⁴⁵, Czechia⁴⁶, Sweden⁴⁷, The

Netherlands⁴⁸) regulate the breeding of companion animals adequately for cats and dogs, by providing clear and adequate rules on minimum mating, weaning period, and maximum number of litters per animal.

Almost half of EU countries restrict extreme breeding practices⁴⁹ (Austria⁵⁰, Belgium⁵¹, Germany⁵², Greece⁵³, Hungary⁵⁴, Lithuania⁵⁵, Romania⁵⁶, Slovakia⁵⁷, Slovenia⁵⁸, Spain⁵⁹) and two countries stand out for their particularly extensive legislation: The Netherlands⁶⁰ and Sweden⁶¹. Latvia⁶² does not restrict breeding activities as such, but prohibits the sale of genetically defective dogs with inherited diseases, pathologies, or malformations.

3.3. Regulation of Sale of Companion Animals

The majority of Member States regulate the sale of companion animals by requiring that sellers follow the same registration and licensing requirements as the ones required for breeders. However, unlike the requirements for breeders, not all countries require that sellers comply with training requirements (only France⁶³). At least nine Member States prohibit the sale of cats and dogs in pet stores: Austria⁶⁴, Belgium⁶⁵,

Croatia⁶⁶, Czechia⁶⁷, France⁶⁸, Latvia⁶⁹, Luxembourg⁷⁰, Spain⁷¹, and Sweden⁷². Most jurisdictions prohibit the display of animals in windows.⁷³ France further imposes a 7-day cooling off period between the delivery of a certificate of commitment and knowledge and the transfer of ownership, so as to prevent impulsive buying.⁷⁴

3.4. Cosmetic Mutilations and Extreme Breeding

Most Member States also prohibit cosmetic mutilations on companion animals as a general rule. However, most Member States only specify that tail-docking and ear-cropping is prohibited and do not provide an exhaustive list of prohibited surgical procedures (as is the case with Belgium⁷⁵, Denmark⁷⁶, and Estonia⁷⁷). Austria and Bulgaria include an exhaustive list of prohibited mutilations.⁷⁸ Some jurisdictions also provide exemptions for certain surgical procedures on certain dog breeds, or certain dog use, such as hunting and working dogs.⁷⁹ Lastly, some jurisdictions, such as Austria⁸⁰, Belgium⁸¹, Germany⁸², and Finland⁸³ go as far as prohibiting mutilations as well as the sale, exhibition, display, and competition of mutilated animals.

3.5. General Treatment of Companion Animals

When it comes to the regulation of the general treatment of companion animals, most jurisdictions provide a general rule prohibiting the permanent tethering of animals, other than for animal health reasons (e.g. Bulgaria⁸⁴, Cyprus⁸⁵ or Czechia⁸⁶). Only a few jurisdictions, however, specifically provide that the tethering of dogs is prohibited – such is the case with Croatia⁸⁷, Germany (although with derogations)⁸⁸, and the Netherlands⁸⁹. Many jurisdictions allow the tethering of dogs but regulate the practice. For instance, French law requires that the animal must have a shelter to protect themselves from adverse weather, sets a minimum length for the tether, and prohibits the use of certain material as a tethering device.⁹⁰ Polish law allows the tethering of dogs but for less than 12 hours a day.⁹¹ Some Member States (Austria⁹², Bulgaria⁹³, Croatia⁹⁴, and Sweden⁹⁵) also explicitly prohibit the use of cruel controlling devices, specifically electric and choking collars, while others simply provide a general prohibition on the use electric devices (Czechia⁹⁶, Germany⁹⁷, and Finland⁹⁸ for instance).

The EU is a party to the Council of Europe's European Convention for the Protection of Pet Animals⁹⁹ to the extent that the EU is bound to the Council of Europe's conventions as a "non-State signatory," and also to the extent that all EU Member States, individually, are members of the Council of Europe.

However, given the non-commercial nature of the relationship between companion animals and humans, the EU institutions have been reluctant to enact rules related to the protection of companion animals. A 2017 ruling by the Court of Justice of the EU thus confirmed the EU's lack of competence in regulating the protection of companion animals.¹⁰⁰

The EU still regulates certain aspects of the lives of companion animals indirectly on account of its competence in regulating transport, animal health, and trade. Compared to other types of animals though, such as farm animals, animals used for scientific purposes, or wild animals, the EU has been less proactive in regulating the treatment of companion animals.¹⁰¹ As a result, aspects such as the commercial breeding and sale of companion animals has mostly been regulated through national laws, which often rely on the European Convention for the Protection of Pet Animals. Because the rules laid down in this European Convention are general, the rules significantly differ from one Member State to another when it comes to the regulation of commercial breeding and sale of companion animals. The publication of the Commission's proposal for a Regulation on the Dogs and Cats Welfare and their Traceability is therefore a positive development.

4.1. The Prohibition on the Sale of Dog and Cat Fur

On the basis of its competence in regulating trade within the EU and with third countries,¹⁰² the EU enacted a prohibition on the import and export of cat and dog fur and any products containing such fur in 2007. The ban entered into force in 2008 and was enacted by way of Regulation 1523/2007.¹⁰³ The ban contained in Regulation 1523/2007 intends to harmonize rules across Member States to ensure the "smooth operation of the internal market" and so as not to mislead consumers into buying fur originating from cats and dogs.¹⁰⁴ However, the primary impetus of the EU Legislature seems to be the ethical implications of the import and sale of dog and cat fur, recognising that "cats and dogs are considered to be pet animals and therefore it is not acceptable to use their fur or products containing such fur."¹⁰⁵

The Regulation therefore bans the sale, import, as well as exports, of fur and fur products originating from dogs and cats.¹⁰⁶ The scope of the ban encompasses fur originating from wild cats for enforcement purposes, considering that “it is scientifically impossible to differentiate fur of domestic cats from fur of other nondomestic cat subspecies.”¹⁰⁷ However, fur and fur products from cats and dogs used “for educational or taxidermy purposes” are exempted from the ban.¹⁰⁸ To ensure uniformity in the ways in which the Regulation is enforced, Regulation 1523/2007 further mandates that Member States inform the Commission of the method they have used to identify the species of origin of the fur.¹⁰⁹

4.2. Transport Rules

The Regulation 1/2005 (Transport Regulation)¹¹⁰ is the only of the seven legislative acts pertaining to the welfare of farmed animals that covers companion animals. EU law thus provides minimum animal welfare standards for companion animals during all transport, by road, rail, air, and sea, taking place “in connection to an economic activity,” from the moment the animals are loaded, until they are unloaded from the vehicles, including during transfer and rest periods (excepting transport of animals to and from a veterinary practice).¹¹¹ The CJEU further found in a 2015 ruling that the Transport Regulation applied to the inter-state movement of stray dogs transported for adoption by an animal protection nonprofit.¹¹²

However, the Transport Regulation does not provide specifications for the transport of companion animals, and provides extremely lax regulations on transport duration. For instance, Regulation 1/2005 provides that “dogs and cats being transported shall be fed at intervals not more than 24 hours and given water at intervals of not more than eight hours” and that “there shall be clear written instructions about feeding and watering.”¹¹³

4.3. Identification and Health Rules

NON-COMMERCIAL MOVEMENT OF COMPANION ANIMALS

On the basis of the EU’s competence in regulating animal health,¹¹⁴ Regulation 576/2013 on the Non-Commercial Movement of Pet Animals¹¹⁵ lays down a series of rules for the transport of cats, dogs, ferrets, invertebrates (except bees and bumblebees), ornamental aquatic animals, amphibians, reptiles, birds, and other mammals,¹¹⁶ who are introduced into and moved within the Union for purposes other than “the sale of or the transfer of ownership of a pet animal.”¹¹⁷ The goal of this regulation is two-fold: ensure animal health, specifically regarding rabies,¹¹⁸ and to prevent the fraudulent inter-state trade of companion animals in the EU.¹¹⁹ To that effect, EU law limits the number of animals that can be moved for non-commercial purposes at once to five.¹²⁰

The rules in Regulation 576/2013 vary depending on the type of animal, as well as whether the animal enters the Union or is moved within it. Among other rules, Regulation 576/2013 requires that cats, dogs, and

ferrets transported within EU borders be identified by way of a transponder,¹²¹ are vaccinated against rabies (following a 21 day waiting period), and that the animal(s) carry an EU pet passport.¹²² Generally, the requirements are similar for persons transporting cats, dogs, and ferrets from a third country,¹²³ except that the animals must travel with a health certificate (instead of an EU pet passport).¹²⁴ Regulation 2016/429 (Animal Health Law)¹²⁵ further requires that, in cases where the owner cannot travel with their companion animal, that the owner be reunited with their animal within five days.¹²⁶

COMMERCIAL MOVEMENT OF COMPANION ANIMALS

For the movement of more than five companion animals, or for the movement of companion animals for commercial purposes, including for re-homing purposes,¹²⁷ additional rules set in Regulation 2016/429 (Animal Health Law)¹²⁸ and Delegated Regulation 2020/692¹²⁹ apply. In principle, the same requirements apply as for non-commercial movement (e.g. identification with transponder, EU-passport, valid rabies vaccination). However, cats and dogs who are commercially moved also need a clinical examination 48 hours before they are transported, must carry a health certificate, and must be registered in the EU's electronic internet database related to the trade of animal and animal-origin commodities (called TRACES). Depending on the country of origin; cats, dogs, and ferrets must further "undergo a valid rabies antibody titration test."¹³⁰

4.4. Online Sales of Cats and Dogs

While EU law does not provide specific rules regulating the online sale of cats and dogs, the general provisions of Regulation 2022/2065 on a Single Market For Digital Services ("the Digital Service Act") apply.¹³¹ The Digital Service Act establishes obligations for online platforms such as social media and online marketplaces, such as traceability measures that ensure sellers can be properly identified. The Digital Services Act further provides enforcement mechanisms to prevent illegal content, as defined by national or EU law.

Some Member States further provide rules regulating the online trade of animals, such as Austria¹³² and Spain.¹³³

4.5. Shortcomings of Existing Rules

While EU law provides basic animal welfare standards during transport, EU law fails to establish minimal animal welfare standards in breeding and selling facilities, such as minimum space allowance, enrichment specifications, minimum breeding and weaning age, frequency rules on litters, and restrictions on selective breeding and mutilations.

Furthermore, EU law does not require that all cats and dogs be identified and registered and Member States have different and often inconsistent identification and registration rules.

Lastly, EU law fails to ensure that all established national databases with cats and dogs microchipping information are interoperable. Yet, such an interoperability would make the identification and registration requirements more effective and reduce illegal conduct, such as abandonment, animal abuse, or trafficking, by ensuring better traceability of the animals.

5. Prospective Change: A New Regulation on the Welfare of Dogs and Cats and Their Traceability

5.1. Scope

The scope of the Proposal for a Regulation on the Welfare of Dogs and Cats and their Traceability only includes some breeding facilities, pet shops, and shelters above a certain number of animals.¹³⁴

5.2. Main Measures

The Proposal for a Regulation on the Welfare of Dogs and Cats and their Traceability includes the following key measures:

- Housing requirements for cats and dogs in breeding establishments, including minimum space allowance, maximum stocking densities, and minimum and maximum temperatures. Dogs must have daily access to an outdoor area or must be walked daily (Chapter II and Annex I).
- Breeding standards, including a minimum age for breeding for reproductive female dogs and cats, a restriction on the number of litter per year, and a prohibition on inbreeding.
- Animal welfare standards, such as a prohibition on painful mutilations (ear cropping, tail docking, removal of claws), unless required for health reasons (Chapter II and Annex I).
- Registration of breeding establishments (Article 16).
- Mandatory identification and registration of dogs and cats into national databases before they are offered for sale (Chapter III).
- Interoperability of national databases between Member States (Article 19).
- Voluntary system allowing users to verify the registration status of the animals advertised online (Article 17).
- Extraterritoriality of EU measures to all dogs and cats entering the Union (meaning all these standards would also apply to breeders operating outside the EU and selling on the EU market) (Article 2).

5.3. Limitations

While the Proposal for a Regulation on the Welfare of Dogs and Cats and their Traceability contains ambitious animal protection measures, the Commission failed to address certain shortcomings.

A first limitation of the proposal is that it exempts the following operators from the scope of the legislation: “breeding establishments keeping up to three bitches or queens and producing in total two litters or less per establishment and calendar year”; “pet shops keeping at any given time three dogs or less or six cats or less”; and “shelters keeping at any given time ten dogs or less or twenty cats or less.”¹³⁵ These exemptions are intended to relieve small breeders, pet shops, and shelters from administrative burdens but appear disproportionate, given that the animals in these facilities face the same risks as those in larger facilities. Moreover, the proposal requires identification and registration only for animals placed on the market, as opposed to all cats and dogs.

A second limitation is that the proposal fails to require online sellers to identify and register companion animals. Instead, the Commission requires online sellers to offer prospective buyers the option to verify that the animals offered for sale are registered,¹³⁶ an approach insufficient to ensure the proper traceability of cats and dogs sold online.

Lastly, the Commission’s proposal does not require Member States to impose robust minimal penalties to deter operators from engaging in cruel practices. It simply provides that Member States should ensure that penalties are “effective, proportionate and dissuasive.”¹³⁷

The European Parliament and the Council of the EU’s Positive Contributions to the Proposal

European Parliament: On June 19th, the Members of the European Parliament voted in favor of amending the Proposal and proposed four key improvements:

- Extending the scope of the Regulation to all breeding facilities, including those with fewer than three breeding dogs and/or cats and breeding less than two litters a year.
- Extending mandatory identification and registration to all cats and dogs, rather than limiting this requirement to animals placed on the market.
- Banning the sale of cats and dogs in pet shops.
- Adding a provision mandating the European Commission to adopt a regulatory list of animal species that can be kept in private homes (“positive list”).

Council of the EU: The key measures in the Council of the EU’s report were:

- Extending the scope of large parts of the regulation to breeding facilities, pet shops, and shelters regardless of the amount of animals kept.
- Mandating breeding facilities to document socialization measures.
- Banning hybrid breeding.
- Banning the use of prong collars and pull leashes without a stop.
- Banning the exhibition of mutilated animals and animals with extreme features.

6. Our Recommendations

1

Cats and dogs must be recognized as sentient beings, as per Article 13, TFEU.

2

The scope of the regulation should encompass all breeders and sellers, including small ones.

3

The extreme breeding of cats and dogs must be prohibited.

4

The mutilations of all cats and dogs, other than for veterinary purposes, must be prohibited.

5

All cats and dogs must be identified and registered.

6

The sale of cats and dogs in pet shops must be prohibited.

7

Online sellers must register cats and dogs they sell before the advertisement is published online. Online platforms are only allowed to present identified and registered cats and dogs; this needs to be checked before an ad goes online.

8

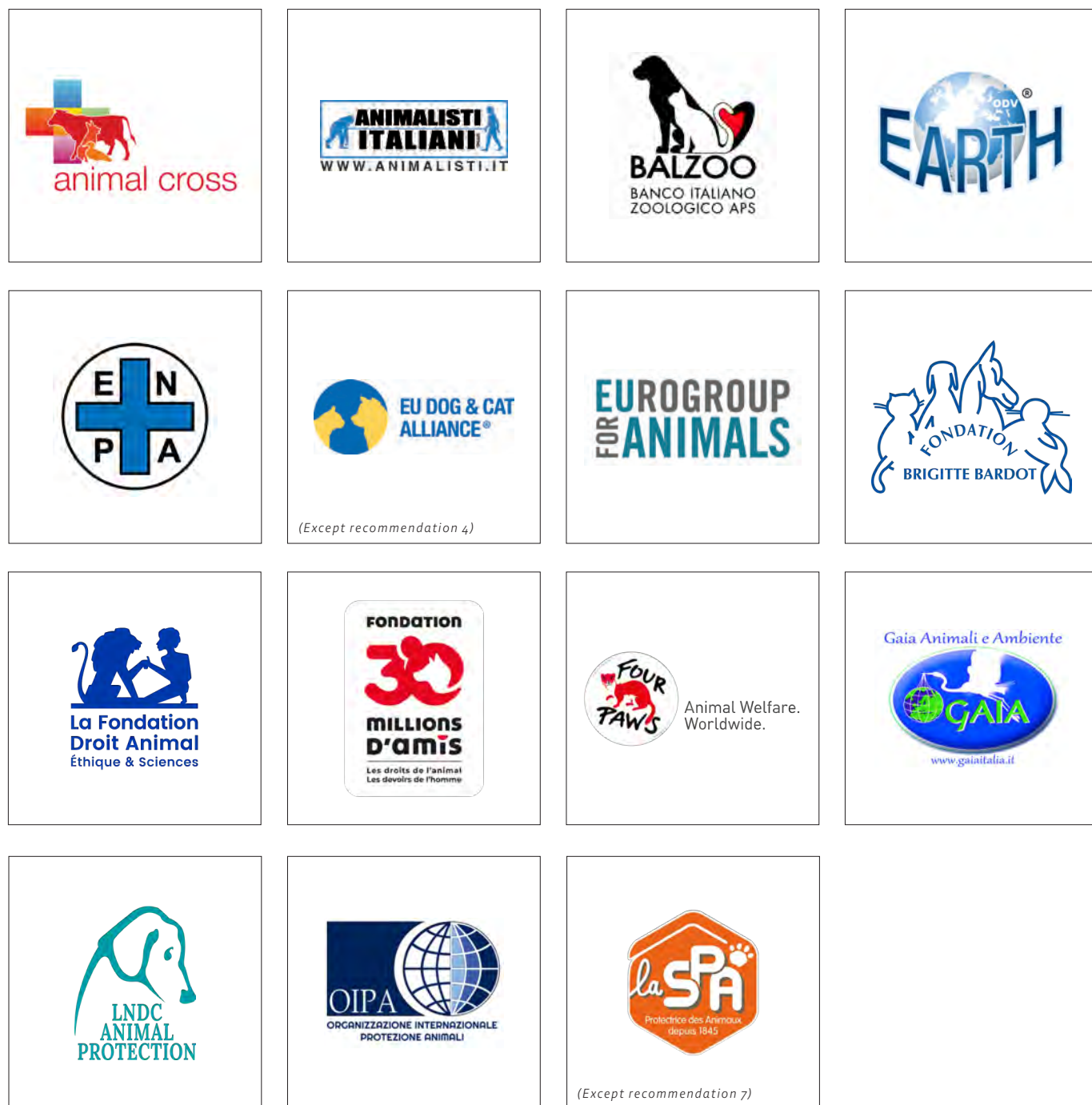
Organizations managing animal databases across the EU must make their database interoperable and abide by strict anti-fraud standards, to ensure their relevance and effectiveness.

9

Member States must provide deterring criminal penalties in national law in cases of violations with the Regulation.

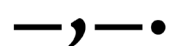
